# Hometown Security Conference: Huge Success! By John H. Daniels

C&SO HIMSS, in conjunction with the American College of Healthcare Executives (ACHE) and the Greater Dayton Area Hospital Association (GDAHA), held a Hometown Security Medical Response Conference at the Hope Hotel & Conference Center located at Wright-Patterson Air Force Base in Fairborn, Ohio.

The conference brought together local healthcare executives and emergency planners and responders in an effort to fill a gap in collaborative planning activities among local and state government agencies as well as local hospitals and Wright-Patterson Air Force Base agencies.

The conference helped participants to understand how the Federal and Ohio emergency response plans related to local disaster response plans and told them about the availability of local, state, and federal disaster response resources.

Additionally, the conference gave participants a chance to meet their local area peers. They heard speakers from the Wright-Patterson Medical Center, the City of Dayton, the Greene County Combined Health District, Ohio's Emergency Management Agency, and the 445<sup>th</sup> Aero-medical Evacuation Squadron.

The speakers answered many questions and spoke about how to access those local, state & federal disaster response resources.

Closer to home, participants learned about local initiatives and were given lessons learned from recent area exercises that could prove useful in their own organizations' planning efforts.

The opportunity to network with their emergency planning peers seemed to be one of the most value added benefits of the conference based on feedback from the participants.

# **Security Conference (cont.):** Conference Statistics:

18% of the attendees were

- 18% of the attendees were members of GDAHA

"...the country needs to think about nontraditional ways to buttress medical surge capacity, including non-hospital alternatives. Possibilities include bringing the military, with field medical facilities, or Veterans Hospitals into response planning for a major attack; developing reciprocity agreements (including liability and worker compensation issues) among states for licensed professional personnel; utilizing gymnasiums, armories, and other facilities for mass-casualty incidents; and networking with home-healthcare providers."

#### Success Story: Cerner-PharmNet Millennium

On December 3rd, 2002, St. Rita's Medical Center converted to Cerner's PharmNet Millennium. Interfaces vital to this conversion included bidirectional HL7 messages to the McKesson Robot and the MedSelect (Diebold) Automated Dispensing cabinets, and a one way outbound billing file to the HBOC Series system.

The project was kicked off in May of 2001, making this an 18 month project from kickoff to conversion. Some benefits for PharmNet have included the ease of use for the end users, (very user friendly), high quality outputs including labels, MARs and other reports, and wide flexibility, allowing unique orders and many other types of customization for self medications or pass medication orders.

The interface with MedSelect has allowed St. Rita's to integrate the decentralized distribution of medications to provide a more complete patient profile. All of these features benefit patient care and safety. It is St. Rita's second step in closing the medication administration cycle, with ordering and administration solutions targeted with future implementations.

This implementation is one of the first steps in a multi phased project, with an organizational goal of Computerized Physician Order Entry (CPOE). To date St. Rita's has built the data repository and are feeding laboratory, radiology and dictated reports into the system. These are easily viewable on nursing stations, from physician's offices and in select physician homes.

St. Rita's Medical Center is also one of the sponsors at the one-day seminar on April 4<sup>th</sup>.
